1. Welcome

Ian Fox opened the meeting.

3. Confirm minutes of previous meeting

There had been some discussion of the minutes via email since the last AGM. Responses have been added to the minutes (see text boxes).

5. Financial report

John Rohde presented the AWA financial report for the period 31/12/2002 – 31/12/2003 (Attached).

7. Receive and consider statement submitted by the association in accordance with section 30(3) of the act.

Last years statement was checked by Bruce McPhail (Public Officer) and submitted to the "Consumer & Business Affairs Victoria", (CBAV). Ian Fox stated that John should contact Bruce to lodge the current financial statement.

8. General Business - General discussion on ;

8.1 Fee Structure:

a) all agreed to keep the current fee structure

b) IWA Class Fees

Formula Windsurfing 160euros IFCA 160euros IMCO 200euros

Initially, we chose to maintain current payments (IWA + IMCO)

lan suggested we add IFCA in response to the resurgence of slalom.

Bill said this couldn't be approved right now, as he needs to put the question to the NSW Boardsailing Association.

Bill stated that, If the IFCA is not made by us (AWA), then the sailors attending the Slalom Worlds would be up for an additional fee (approx 25euros each).

Following this discussion, Ian Fox proposed that we should now review support for payment of ALL the fees (FW/IFCA/IMCO) at State level and respond by the end of February, 2004. All agreed.

8.2 Venues for next Australian Championships:

Raceboard/Mistral 2004 Bill – NSW by default.

NSW also expects to host the 2005 nationals, but the event name and classes to be raced will depend on what is chosen as the next Olympic board.

Slalom 2005 WA again

The suggested date is the week preceding the Ledge to Lancelin event (ie. The 4 days immediately before the L2L). Victoria has expressed interest in hosting a future Slalom Nationals, but, its current emphasis is on Formula Windsurfing.

Formula 2005 Ian – Combine with Sail Melbourne event.

This is subject to the sailors opinions at the current event. Tasmania is interested in the 2006 event, especially if held back-2-back in conjunction with Sail Melbourne. Queensland not interested for coming season. SA to get feelings from its sailors about hosting future events. It was commented that such an event could be a boost to participation in SA.

Windsurfer 2004 Mooloolaba, Queensland (organised by NSW)

8.3 National Initiatives

a) Sail Number Register

All happy with it. WA questioned its necessity.

b) Measuring

Procedures and Policies for Formula Windsurfing are not yet finalised. At the current event (FW Nationals) boards and fins are being measured.

- c) Website
 - Ian suggested that generic email addresses for President, VicePres, Sec, etc would help hide the committee from SPAMers. The mail would then be redirected to the appropriate person.
 - John has obtained the domain "windsurfing.org.au" and will point it to the main site soon.
 - John to check that "Windsurfing Tasmania" is correctly named on the site.

8.4 Liability Insurance

Offshore insurance is not permitted by some bodies in NSW (ie. Waterways Authority, Local Councils) and could be a problem (Bill).

lan will get an additional quote this year (may not be as watertight). He requested that any State that has any additional insurance quotes/opportunities, bring them to the attention of the AWA before the end of May, 2004. The Triton (policy) renewal decision will be made by July 1st.

Is APRA approval important?

We need a "form" for one off insurance payments. One off/event insurance is risky as the policy only covers members. They should be honorary members for the duration of the event. OS competitors pave paid insurance fees and appropriate documentation created. The competitor and AWA (and host State) should have a copy.

Ian congratulated John for his efforts as Secretary/Treasurer, and with the website.
