1. Welcome

Brett Morris (chairperson) opened the meeting at 8:10pm Sydney Time. JohnR thanked by all, for carrying out the required Administration Duties.

2. Apologies

3. Confirm minutes of previous meeting

Confirmation of the minutes was moved by Brett Morris and seconded by Ian Fox

4. Matters arising from previous minutes

Scott commented that insurance was too expensive. Discussion continued in General Business.

5. Financial report

John Rohde presented the AWA financial report for the period 31/12/2009 – 31/12/2010 (Attached).

- Brett commented that 2 invoices for \$1000ea are coming for the Wavesailing and Formula Nationals. AWA to pay on receipt.
- Comment made by Ian that expenditure was \$1000 more than income and we should cap national event grants at about \$1000. JohnR reminded meeting that there was an overall \$3000 grant limit.

7.1 Public Officer

Ian Fox was re-elected as the Public Officer

The "Australian Windsurfing Assoc. Inc." was incorporated in Victoria on 1/12/1995. The incorporation followed a name change to Australia's then peak windsurfing body, AUSA (Australian Union of Sailboard Associations). The Public Officer must be a resident of Victoria.

8.1 Membership Numbers:

8.2 Fee Structure:

Brett proposed that the fees remain the same. All agreed.

- The affiliation fee is currently \$3 per member, with a maximum of \$600
- Affiliation fees are payable in February, and are based on State insurance numbers at 30th June, the preceding year (excluding insurance only payments).

8.5.1 Website

Non-AUS numbers removed from the web site.

- No 3-digit numbers.
- Cull overdue
- Brett reiterated desire to display sail number availability like NZ does on its website.

8.5.3 Liability Insurance 2011/2012

To be discussed in June 2011 when the policy renewal costs are known

The current premiums to be collected from each state for the 2010/2011 policy are the same as set the previous year for the insurance cover i.e.

\$10 for non-competitive members (social, not racing)

\$15 for competitive members

Further discussions followed on what was covered.

States need to explicitly remind members that the cover is not 24/7, and where to look for further information. ie. http://windsurfing.org/insurance.htm

Also, members should be reminded to see if/how their home insurance covers windsurfing equipment and activities.

In mid 2011, the Insurance fees were set at \$15 per member, for the 2011/12 season.

8.5.4 Insurance Register

JohnR was congratulated on the rapid update of the register as states supply updates. States to keep the list up-to-date by providing names to John ASAP.

8.5.5 National Calendar of Events

Brett to follow-up.

8.5.6 Strategic Plan/Budget for AWA Expenditure

AWA to support events by funding expenses for interstate event organisers/judges to attend National events. \$3000 budgeted as per last year, with \$1000 max per event.

- Brett/lan suggested that grants should be sought in advance of an event, rather than afterwards.
- Proposals to extend grants to non-national events were abandoned as they were more "state support" rather than supporting "the sport nationally".

8.6 Common Branding

Idea has merit, but timing isn't right?

All states to look into it for review at next AGM.
