1. Welcome

Ian Fox (Chairperson/President) opened the meeting at 8:05pm Melbourne Time.

5.1 <u>Financial Statement (2021 calendar Year)</u> attached to these minutes

- The PO Box is shared with Windsurfing SA. In 2021, the AWA paid the bill and sought 50% refund from that state association

Motion#2 – Ian proposed that the Financial Statement be accepted as correct. Seconded by Richie. MOTION CARRIED

5.2 <u>Budget</u> (2021 & 2022 documents sent with meeting notice) A copy of the 2021 AWA Budget Status was presented to the meeting. The green and red amounts match the total income and expense amounts in the official Financial Statement. A draft 2022 AWA Budget was also presented.

5.3 Account Access

At least 2 members of the committee need to have access to the accounts and financial records of the association [Rule 48 (3)]. The account is held with NAB. See also, Rule 69 Management of funds

A signed copy of the AGM minutes may be required.

WA reported that they used 2 (bank supplied) dongles for authorisation of transactions via their bank account (Westpac).

AWA account currently only requires one to make a payment. Having an alternate person with access is necessary.

It was also suggested that we should try and get the monthly charge removed from the account. And that we try and get a dongle approval system established too. Even changing banks if necessary.

Motion#3 – Tim proposed that John find out what's required for Ian to be added. Signed minutes of the AGM may be required. Seconded by Jo. MOTION CARRIED

5.4 <u>Set Authorised Payment Limit</u> [Rule 69 (3)]

Those attending reaffirmed the 2020 motion (see below)

<u>2020 Motion</u>: The committee authorises the Treasurer to expend funds on behalf of the Association up to AU\$1000 (including by electronic funds transfer) without requiring approval from the committee for each item on which funds are expended.

5.5 Consumer Affairs Victoria (CAV) Statement

The Association is incorporated in Victoria. They require the lodgement of our Annual Statement within 1 month of the AGM date.

7.2 <u>Fee Structure for Affiliation Fees</u>:

The meeting discussed raising the per member fee (see 8 "Strategic Plan". The outcome was that all agreed to keep it at \$3 per member and to remove the \$600 maximum (see below)

- previously each State paid \$3 per member, with a maximum of \$600

- based on State insurance numbers at 30th June

- to be paid in the following February ie. in the 2023 financial year

7.3 Liability Insurance 2022/23

Ian has begun discussions with the underwriter. The invoices are expected in June with a possible 10-15% increase. There may also be an increase due to our higher membership counts.

The meeting decided to continue the existing arrangement (see below)

20 million cover

The 2022-23 AWA Insurance fee will be the same as this season ie. \$15/member (plus \$3 for affiliation bringing the total AWA fees to \$18/member). Only to be revised later if the new insurance premium justifies it.

As of 15/10/2020, Wing Surfing & Wing Foiling are covered.

With respect to the IWA Fees, for 2023, we are considering dropping IFCA. A decision on which classes we will support will be made when the renewal invoice arrives in January.

IWA is paid for "Limited Membership" of the relevant classes (see below) iQFOiL fees go to the relevant iQFOiL association. For 2022, iQFOiL was split into 2 classes (1) International iQFOiL Class Association, and (2) International iQFOiL Youth & Junior Class Association

IWA National Class Association Annual Membership

Membership - €200 per class: one vote at the Class AGM, one vote (per class) at the IWA AGM, unlimited number of representatives of your country may take part in IWA sanctioned* class championship events per year (subject to qualification restrictions if applied).

For developing nations and those National Class Associations (NCA's) that are unable to be fully represented at class world and continental championships: Limited Membership (LTD) - €100 per class one vote at the Class AGM, one vote (per class) at the IWA AGM, NB: Only up to two representatives of your country may take part in IWA sanctioned* championship events per class per year. Class secretaries are urged to check competition entry lists which will also be monitored by IWA.

7.6 Review of National Initiatives

WA has shifted from TidyHQ to AS's Revolutionise Sport system for memberships. AWA should look at moving there too. Integrating states under AWA via RevSport could help streamline John's membership recording tasks.

For some states, being on RevSport as a "club" could be too expensive.

Tim spoke about everyone migrating to AS's RevSport platform. Richie spoke about the NSW Club affiliation mix

Ian summarised - we resolved to discuss further after the AGM. We'd like to automate the whole membership application system if possible, and somehow link our internet presence through one site.

John applied for the "windsurfing.au" domain. We will have to wait a few months to see if the application is successful.

Last year there was some concern with keeping the windsurfing.org.au domain because we (AWA) were not registered with the Australian Charities and Not for Profit Commission. At domain renewal time, our Incorporation status was recognised, and John didn't need to approach ACNC after all.

New rules for .au domain names take effect on 12 April 2021 and contain changes which may affect your eligibility for the domain name:

windsurfing.org.au windsurfingsa.org.au

What the change is

The org.au namespace is for use by not-for-profit entities. In the new licensing rules, the definition of the a not-for-profit entity has been updated and no longer includes unincorporated associations which are not registered with Australian Charities and Not for Profit Commission (ACNC) cannot hold domain names in the org.au space.

Registry data indicates that the org.au domain name listed above is registered to an unincorporated association.

The "windsurfing.org" domain was due for renewal this month. John renewed it, in advance, last year. The new expiry date is May 2030

Richie stated that knowing what we will support would he helpful to applicants.

Suggestion to increase member affiliation fee to provide a pool of funds for grants.

Motion#4 – Ian proposed that we remove the current affiliation cap (\$600 at 200 state members). Seconded by Tim MOTION CARRIED

Motion#5 – Tim proposed that next year, we increase the (\$3) fee, and provide justification for the increase (ie. What we would use the funds for). Seconded by Jo MOTION CARRIED
