



THIS AGREEMENT made the _____ day of _____ 20____
and between the **[insert State Assoc Name]** of [insert address] of the one part (described herein as “The State Windsurfing Association”) and **[insert Club Name]** of [insert address] of the other part (described herein as “The Club”) **WHEREAS** “The State Windsurfing Association” is an Association incorporated under the Associations Incorporations Act for the purpose of co-ordinating and regulating the sport of Windsurfing in [insert state] **AND WHEREAS** “The Club” is a Club, a member club of “The State Windsurfing Association”, the Members of which engage in the sport of Windsurfing **AND WHEREAS** “The State Windsurfing Association” provides public liability insurance coverage to its Member Clubs **WHEREAS** the Clubs pay an annual Affiliation Fee to “The State Windsurfing Association” **AND WHEREAS** the parties wish to record certain terms of their relationship **NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. “The Club” shall pay “The State Windsurfing Association” an Affiliation Fee of [insert amount in text] Dollars (\$150.00) per annum which is to be paid on or before the 31st July in each year relating to the year commencing 1st July and ending on the 30th June in that year. The amount of the affiliation fee may be varied from time to time as agreed.
2. “The Club” agrees that in conducting windsurfing sporting events it shall adhere to the Risk Management Plan provided by “The State Windsurfing Association” as amended from time to time and in accordance with the requirements the Insurers of “The State Windsurfing Association” or as otherwise deemed necessary by “The State Windsurfing Association”. Copy of the Risk Management Plan, currently in force, is annexed to this Agreement.
3. In the event that “The State Windsurfing Association” amends the Risk Management Plan it shall promptly provide a copy of same to “The Club”.

4. “The Club” shall promptly inform “The State Windsurfing Association” and “Australian Windsurfing Association” of its proposed calendar of events as soon as possible after the 1st July in each year so as to permit “The State Windsurfing Association” and “Australian Windsurfing Association” to publish an overall calendar and arrangement insurance.
5. “The Club” shall as soon as possible provide “The State Windsurfing Association” with a list of the names and addresses of all its paid up members so as to enable “The State Windsurfing Association” to procure insurance coverage. “The Club” shall provide “The State Windsurfing Association” with a list of any new members or members who have resigned including their full names and address so as to allow “The State Windsurfing Association” to update its insurance records and to maintain insurance coverage provided that such report is not required when “The Club” has no new or resigning members.
6. “The State Windsurfing Association” will from time to time notify “The Club” of any levy required to be paid for insurance coverage and “The Club” shall pay the amount of such insurance levies to “The State Windsurfing Association” within one (1) month of such notice.
7. Any notices served under this agreement can be delivered by ordinary prepaid post to the address of the parties shown in this agreement or such new address as is notified to the other party.
8. **GST**
In the event that “The State Windsurfing Association” is liable to pay GST upon any sums received from “The Club” pursuant to the New Tax System (Goods and Services Tax) Act 1999 then it is agreed that the amounts agreed to be paid by “The Club” to “The State Windsurfing Association” expressed in this agreement are exclusive of GST and that the additional amount of liability of GST of “The State Windsurfing Association” in respect of any such taxable supply shall be payable by “The Club” to “The State Windsurfing Association” at the same time as the payment to “The State Windsurfing Association” of the relevant amount.
