### 3. Resolutions

### Resolution #1:

Subject to the Constitution Corrections (listed below),

IT WAS RESOLVED BY SPECIAL RESOLUTION to adopt the new Rules which are enclosed at Annexure "A" (Notice of meeting with new rules-signed.PDF) in replacement of the current Association's Rules. The New Rules will come into effect on July 1st, 2019

When the corrections have been made, the New Rules will be submitted to Consumer Affairs Victoria for approval.

#### Explanatory Notes

The current rules do not adequately provide for the unique structure of Membership of the Association. The proposed rules allow for the structure of the association to operate in a more effective way. The proposed rules also provide sufficient cover to encapsulate individuals for insurance purposes at special events.

For this resolution to pass, 75% of the Members eligible to vote must vote in favour of the proposed resolution.

# 2) Correct Rule 12 (4) to read

"ISAs will be liable to pay amounts for insurance which are negotiated or paid for by the Association on behalf of their SAMs."

## Resolution #2:

IT WAS RESOLVED to update the registered office of the AWA to C/-Coulter Roache, Level 1, 235 Ryrie Street, Geelong, Victoria 3220.

#### Explanatory Notes for Resolution #2

The Registered Office of the Association must be in Victoria, hence the adoption of the lawyer's address. This is separate issue to the postal address which is that of the Public Officer unless stated otherwise (ie. the PO Box). Events like Green Island are required to have a registered office to serve notices. An office address that is not a PO Box.

### 4. 2019/20 Insurance

### Resolution #3:

IT WAS RESOLVED to change our Insurance Broker to V-Insurance Group Pty Ltd Level 25 Angel Place, 123 Pitt Street, Sydney NSW 2000

It was felt that the new broker would represent us better. The underwriters would remain the same. Our previous broker was World Wide Sports Insurance (WWSI). Ian to write to each broker, notifying them of the changes.

V-Insurance should be able to negotiate with ATC to renew our existing policies and include extension to (Australian Sailing) Yacht Club events that's been sought without the need of Australian Sailing or the YC's to need to provide their CoC's. Alternatively, V-Insurance will have a different insurer available for slightly more cost and less features.

There will not be an insurance cover gap during the financial year/cover changeover.

#### The Policies:

- 1) Third Party Liability insurance covering State Association members \$6,000 approx.
- Management Liability insurance covering the management committee \$1,500 approx.

# 5. Other Business

# 5.1. TidyHQ

Discussed whether AWA should implement a top down membership system where AWA receives all monies and feeds it down to the relevant states and clubs rather than the reverse money flow.

NSW and Queensland complicate implementation due to having sub-clubs. The other states can easily move onto TidyHQ to manage their sate association.

A full top down scenario may be cost prohibitive if TidyHQ charges \$16k/year. At state level, \$40/month might be more affordable for the convenience TidyHQ provides.

Sub Clubs and WCAA may already be using Australian Sailings "Revolutionise" system which works like TidyHQ

Courses may have to highlight how the Windsurfing Admin system works.
